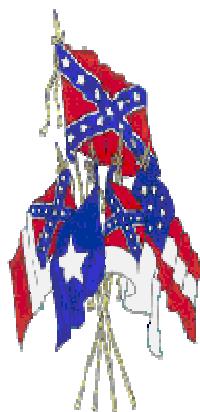

#### **Sustaining Membership**

At the May, 2005 meeting the CCWRT membership approved an amendment to the Constitution creating a membership category called Sustaining Members. ### **Quiz—May, 2006**

1. On 18 May 1864, the *New York World* and the *Journal of Commerce* published a hoax about an alleged proclamation issued by President Lincoln. The President believed the story to be traitorous, and ordered the arrest of the newspapers' staff and occupation of their offices. Both editors claimed to be victims of a fraud perpetrated by a stock manipulator. What was the false proclamation?
2. Grant's land forces in front of Vicksburg had no mortars with them for their siege operations when the siege began on May 18. They were able to locally fabricate cohorn mortars for six or twelve pound shells, and used them successfully to shell the Confederate trenches. Of what material were these coehorns fabricated?
3. Name the Confederate officer who began the war in command of a company-sized unit named the "Raccoon Roughs", which joined the 6<sup>th</sup> Alabama Infantry of which this officer soon was elected commander. He ultimately commanded a corps.

4. Name the five Confederate generals killed or mortally wounded at Gettysburg.

5. Petersburg was important as the junction of several railroads, including the South Side, the Petersburg & Weldon, the Norfolk & Petersburg, the Petersburg & City Point, and the Richmond & Petersburg. Outside the Union lines was another railroad that carried as many as fifteen trains of food and ammunition per day during the siege. It was described as “an up-and-downhill affair...no pretense of grading...soldiers declared it made them seasick to ride on its cars...it looked in the distance like a fly crawling over a corrugated washboard.” What was the name of this railroad?

6. BG Horatio Wright of Connecticut was commander of the Department of the Ohio in Cincinnati during the Confederate invasion of Kentucky in 1862, for which service the modern City of Fort Wright is named for him. As a West Point cadet in the Class of 1841, he finished second in his class and chose the prestigious Corps of Engineers as his branch of service. His classmate who finished 11<sup>th</sup> in the class (of 55) was also from Connecticut, but took the unusual step of choosing the Infantry branch, because he thought it would lead to faster promotions. Who was he?

### **Book Review by Thomas L. Breiner**

*Dissonance: The Turbulent Days between Fort Sumter and Bulls Run* by David Detzer, Harcourt Books Inc. Orlando, FL, 2006, 371 pages, Hard cover \$27.00.

Dissonance: The Turbulent Days between Fort Sumter and Bull Run by David Detzer is a detailed look at the opening weeks of the Civil War. The author, through the use of diaries, letters and newspaper accounts, examines the significant events during what may have been the most crucial period of the war for both sides as they move from a peace time status to a war footing. It was a situation that no one on either side really understood.

During these critical weeks, Washington, D.C. was briefly cut off from the rest of the North. If the Confederacy has captured the Union capital, Great Britain and France might have recognized the Confederacy and possibly formed an alliance. This work devotes much of the time analyzing the several events: Henry Wise’s conspiracy to take Virginia out of the Union and the capture of Harpers Ferry, the mob violence in Baltimore, MD as the Sixth Massachusetts is attacked by the citizens of that city, the Confederate take over of the Gosport Navy Yard, the struggle as the Seventh New York and Eight Massachusetts attempt to reach Washington through Annapolis and finally the importance of a slave named Luke.

The author’s analyzes the question could the Confederacy have attacked and captured Washington, D.C. during the period April 23<sup>rd</sup> and April 25<sup>th</sup> of 1861. His insights and comments were extremely interesting and very thought provoking. David Detzer looks at the numbers of troops available, where they could be found, how would they be transported, and most important, who would command this campaign. The possibilities included, Jefferson Davis, Robert E. Lee, P. G. T. Beauregard and Ben McCulloch.

I found this work to be extremely well research and written. The author has show a true ability to get to the heart of a question and give the read the information necessary to form their own opinion of how the events that shaped the early days of the war may have played out. He investigates what incentive was offered to keep Robert E. Lee in the Union army. Was Lee the obvious choice to lead the Virginia militia or may have Joe Johnston really have been the first choice of Virginia Governor Letcher?

This book is must reading for those that want to rethink the understanding of the early days of the Civil War. The approach is different and refreshing. David Detzer and now contributed three quality works concerning Civil War. His earlier works include Allegiance: Fort Sumter, Charleston, and the Beginning of the Civil War and Donnybrook: The Battle of Bull Run, 1861. Now, he has filled in the gap between the two and has done it extremely well.

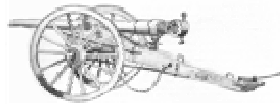

## ABOUT THE CINCINNATI CWRT

**Membership** in the Cincinnati CWRT is open to anyone with an active interest in the American Civil War. Annual dues (prorated throughout the year to new members) are \$25 for a Regular Membership. This fee helps cover operating costs which include this newsletter, as well as speaker expenses. A Sustaining Member level of membership is also available. Sustaining members are members who have made financial contributions of \$25 or more in addition to their annual dues in any fiscal year. The purpose of this membership

category is to encourage and recognize members who make additional contributions to the objectives and programs of the Cincinnati Civil War Round Table. If you are joining for the first time, there is a one-time initiation fee of \$20.

**Meetings** are held the third Thursday of the month at the Quality Hotel and Suites, 4747 Montgomery Road, Norwood, Ohio (**telephone 513-351-6000**). If traveling Interstate 75, exit at Exit #7, Ohio 562 (The Norwood Lateral) and travel east to the Montgomery Road exit. After exiting, "double-back" by turning left across the bridge, turning left again after the bridge, and turning left at the light onto Montgomery. If coming from Interstate 71, also exit at Exit #7, Ohio 562 (The Norwood Lateral) and go west to the Montgomery Road exit. After exiting, continue straight to the light and turn left onto Montgomery. The Quality is on the right, and there is plenty of free parking.

**Dinner reservations** are required, and can be made prior to the reservations deadline either by an email to [reservations@cincinnatiwrt.org](mailto:reservations@cincinnatiwrt.org) or by a phone call to the officer taking reservations for the meeting (whose name and number is listed on the header of the current *Canister*). **Late reservations** (after Sunday prior to the meeting) will be accepted, but will cause an adjustment of arrangements with the Quality, and may require an alternate meal selection, depending on total attendance. **Walk-ins without a reservation** will be able to have dinner if available based on total attendance. **Late cancellations** may be made by email or phone. Since a cancellation after the Sunday deadline means that CCWRT has guaranteed payment to the Quality for the reserved number of meals, the Treasurer will review the number of late cancellations and late reservations for every meeting. If a late cancellation results in CCWRT being required to pay for an extra meal, the person making the late cancellation will be expected to pay for the dinner. **No-shows** who have a dinner reservation but do not attend or cancel will be expected to pay for the dinner. **Meals** currently cost \$20. Menu selection will change with each meeting.
